- II. Approval of 05 March 2018 minutes

III. Treasurer's Report

- A. Last month we voted to pay double the mortgage to lower the balloon payment that's due in 36 months.
 - a. When we overpay the mortgage, it does drop the interest amount.
- B. \$2341.96 is what is needed to truly pay off the balloon before the due date. It's actually triple the monthly mortgage.
 - a. 36 months at 5%
